“International Journal of Cardiovascular Academy (IJCA)” is an official journal of the Cardiovascular Academy Society, publishing every 3 months in both print and online versions and open access on cardiovascular diseases. This journal offers you the option of making your article freely available via the Science Direct platform.

INTRODUCTION

IJCA is an international, open access, peer-review journal, devoted to cardiologists, cardiothoracic surgeons, internists, radiologists, pulmonologists and physicians in training.

IJCA publishes case reports, clinical images, brief communications, meta-analyses, article reviews, debates and author biographies in the field of cardiovascular diseases in every March, June, September and December in both print and online versions.

IJCA is included as part of Science Direct electronic service and all articles published in the journal are sited in Science Direct. Accepted papers are published within 3 months of acceptance.

The papers will only be accepted for publication if they are of a high scientific standard, written in English, submitted in accordance with the Journal’s instructions to authors and consistent with the aims and scope.

SUBMISSION OF MANUSCRIPTS

The Journal solely accepts online submissions in electronic format submitted through (ELSEVIER) and you will be guided stepwise through the creation and submission of your files. Authors are requested to upload the text, tables, and figures in electronic form to this address. The system converts source files automatically to a single PDF file of the article, which is used in the peer-review process. Please note that even though manuscript source files are converted to PDF files at submission for the peer-review process, these source files will be needed for further processing after acceptance. All correspondence, including announcement of the Editor's decision and requirements for revision takes place by e-mail, eliminating the need for a paper trail.

Submitted manuscripts should not have been previously published or be under simultaneous consideration for publication by any other Journal (except in the form of an abstract or as part of a published lecture or academic thesis or as an electronic preprint: <http://www.elsevier.com/postingpolicy>).

The corresponding author takes primary responsibility for the article during submission and review process. Submission of an article commits that the work has not been published elsewhere before and it is approved by all authors. The submitted article, if accepted, will not be published in the same form in any other languages without written consent of the publisher.

Article Structure

General Instructions

The text should be in single-column and in the native format of the word processor ('Times New Roman' font, size 10). The electronic text should be prepared in a way very similar to that of conventional manuscripts (see also the Guide to Publishing with Elsevier:

<http://www.elsevier.com/guidepublication>).

The manuscript should be arranged as follows: Title page, Abstract, Keywords, Introduction, Methods, Results, Discussion, and References. All pages must be numbered consecutively, beginning with the title page.

Manuscripts should be written clearly in English. Authors whose native language is not English are strongly recommended to arrange their manuscripts to be written in idiomatic English before submission. Authors may wish to use the English language editing service available from Elsevier's WebShop. See External link [http://webshop.elsevier.com /languageediting/](http://webshop.elsevier.com/languageediting/) for more information.

Covering Letter

A covering letter should be written by the main author requesting the publication of the manuscript and assuring that the other authors have read the manuscript and agreed to its submission.

Title page

The title page should list the title of the article, full names, institutional addresses and email addresses of all authors. The corresponding author should also be noted. The title page should be accurate and avoiding abbreviations.

Keywords

The main content of the article should be represented by three to ten keywords, separated by semicolon

Figures and Tables

Figures and Tables must be referred to in the manuscript. The tables should be numbered consecutively in accordance with their appearance in the text. Footnotes must be placed to tables below the table body indicated by superscript lowercase letters. Vertical rules must be avoided. The data presented in tables must not duplicate results described elsewhere in the article. The artwork files should be in an acceptable format (TIFF (or JPEG), EPS (or PDF), or MS Office files) and with the correct resolution. Please do not supply files that are optimized for screen use and too low in resolution and graphics that are disproportionately large for the content.

Reference style

Significant references should solely be included. References must be indicated by number(s) in square brackets in line with the text. All references must be typed out at the end of the article on a new page. Index Medicus abbreviations of periodical names should be used. Author(s), title, journal, year, volume, issue, and first and last page numbers must be provided for each periodical article; if an article has more than six authors, list the first three and add 'et al.' (see example below).

Types of Manuscripts

Case Reports

Case reports should describe a new disease, or confirmation of a rare disease; a new insight into pathogenesis, etiology, diagnosis, or treatment; or a new finding associated with a currently known cardiovascular disease.

Case report should include a title page, an abstract and introduction, followed by the case report and discussion. The length should ordinarily be 1,500 words maximum, with no more than 3 figures and 10 references.

Clinical images

Original clinical diagnostic and therapeutic images are considered for publication. The images must be accompanied by a brief history and dissection followed by a conclusion. IJCA does not publish video case studies.

Brief Communications

A brief communication is a short research articles intended to present results of original fundamental research in the field of cardiovascular diseases. Text must not exceed 3000 words (not including abstract, tables, figures and references), 3 figures/tables in total and 30 references. An abstract of 250 words or less should be included with no subdivision of text into sections. Authors should state that subjects have given their informed consent and that the study protocol has been approved by the institute's research committee. The type of statistical analysis used must be stated together with the commercial software. The statistical analysis should define the probability values and prove that the differences reported were found to be statistically significant.

Article Reviews

Reviews should aim to summarize and evaluate research critically in the field and to identify future implications. There will be a maximum of three reviews per issue. It is expected that the authors of review articles are experts in the related field. The length of the review article is within the discretion of the author however should be in reasonable limits with no more than 5 figures, tables and 50 references. The Editor-in-Chief can be consulted regarding reviews of unusual length.

Meta-analysis

A meta-analysis is a quantitative synthesis of the results, critical assessments of literature and data sources within maximum 3000 words of text, total of 5 tables and/or figures and 50 references.

Debates

Controversial issues or topics in cardiovascular medicine are discussed by invited experts in Debates as the format of a general introduction from the proposer and opposer, followed by a constructive critique of each other's point of view and any concluding remarks.

Author biography

Each submission should include a short biography.

Announcements are also published in IJCA.
